On September 1, 2023, Chesapeake Utilities Corporation ("Chesapeake") filed with the Commission an application (the "Application") seeking approval of an Energy

Efficiency Program including a recovery mechanism that has been recommended for

Commission approval by the State of Delaware Energy Efficiency Advisory Council.

THE EVIDENTIARY HEARING

Evidentiary hearings are conducted to formally introduce evidence into the record and to make available for cross-examination the parties' witness testimony, including testimony that may be offered with respect to any settlement agreement that may be reached by the parties prior to the hearing. Members of the public are invited to attend the evidentiary hearing as observers, but only the parties are permitted to present or cross-examine witnesses. At the evidentiary hearing, the Commission will consider the Application, the pre-filed and live testimony of the parties and any other pertinent documents submitted by the parties, including any settlement reached by the parties prior to the hearing. The Commission is obligated to reach a decision based on the evidence presented at the evidentiary hearing. If a settlement agreement is reached, the evidentiary hearing will address whether it is in the public interest for the Commission to approve the settlement agreement.

Persons or entities that were granted intervention in this docket may present witnesses, conduct cross-examination, or introduce evidence at the evidentiary hearing. Members of the public are welcome to attend the evidentiary hearing as observers.
