The evidentiary hearing is being held in accordance with 26 *Del. C.* § 503 and 29 *Del. C.* §§ 10122, 10124, and 10125. Anyone planning to attend the evidentiary hearing should consult the Commission’s website prior to the event for any change or cancellation in the time, location, or date.

On August 30, 2024, Chesapeake Utilities Corporation (“Chesapeake” or the “Company”) filed with the Delaware Public Service Commission (the “Commission”) an application (the “Application”) pursuant to 26 *Del. C.* §§303(b), 304, and 306 seeking to change its Gas Sales Service (“GSR”) Rates as follows:

GLR, GLO	\$0.513 per Ccf	\$0.505 per Ccf
HLFS	\$0.815 per Ccf	\$0.813 per Ccf

Compared to the rates currently in effect, an average RS-2 customer using 700 Ccf per year will experience an annual increase of approximately 4.91%, or \$4.14 per month. During the winter heating season, a typical RS-2 customer using 120 Ccf per winter month will experience an increase of approximately 5.61%, or \$8.52 per winter month.

The Company has also proposed the following changes to its firm and interruptible balancing rates for transportation customers:

By Order No. 10553 dated October 9, 2024, the Commission has permitted the proposed GSR and other rates to become effective with usage on and after November 1, 2024, subject to refund and pending the Commission’s final decision after evidentiary hearings and any other proceedings that may be necessary.

The Commission will conduct an evidentiary hearing on the Application as set forth above. Evidentiary hearings are conducted to formally introduce evidence into the record and to make available for cross-examination the parties’ witness testimony, including testimony that may be offered with respect to any settlement agreement that may be reached by the parties prior to the hearing. The Commission’s final decision will be based on the evidence presented at the

evidentiary hearing.

Only those persons or entities who are parties or were granted intervention in this docket will be allowed to present witnesses, conduct cross-examination, or introduce evidence at the evidentiary hearing. Members of the public are welcome to attend the evidentiary hearing as observers.
